While FCPC welcomes postings from the community, FCPC reserves the right to block individual accounts and/or remove comments, links, photos or other content from the social networking sites for any reason, including but not limited to, harassment and personal attacks, derogatory or defamatory comments, vulgarity and profanity (including expletives and letters followed by dashes), commercial promotion, off-topic posts, improper use of intellectual property or copyrighted material, or otherwise inappropriate content.
