Bodwéwadmī Ktëgan Welcomes New Residents

On Friday, August 14, 2020, Bodwéwadmī Ktëgan (Potawatomi Farm), officially welcomed two new residents of the four-legged kind all the way from Yellowstone National Park. This exciting acquisition was made possible by the Intertribal Buffalo Council (ITBC).

According to its website, "ITBC is a federally-chartered tribal organization with a membership of 69 federally-recognized tribes from 19 states whose mission is to restore buffalo to Indian Country to preserve our historical, cultural, traditional, and spiritual relationship for future generations. To reestablish healthy buffalo populations on tribal lands is to reestab-

lish hope for Indian people. Returning buffalo to tribal lands will help to heal the land, the animal, and the spirit of Indian people."

The Forest County Potawatomi Community (FCPC) is a member of ITBC. When ITBC put out a request for proposals a couple of months ago stating that they would have 40 Yellowstone bulls available, FCPC applied and was awarded two animals. The other 38 were transferred by ITBC to 16 Native American tribes in nine states. These transfers will help develop and sustain tribally-managed buffalo herds while preserving the unique genetics and lineage of the largest and continuously free-roaming buffalo herd.

Yellowstone bison were normally rounded up every year and sent straight to slaughter. ITBC has worked for almost 30 years to make animals from Yellowstone available to tribes, and this year marks the first distribution of them. In order to keep the animals healthy and to make sure they did not carry any disease – the main focus being brucellosis, ITBC built a quarantine facility in Fort Peck, Mont. According to an ITBC press release, "Those that test negative for the disease brucellosis may enter a quarantine protocol which varies by age and sex, and which ends with their transfer to the Fort Peck Assiniboine and Sioux Tribes in Montana to complete post-assurance testing. After a final negative test result, they are declared brucellosis-free by the state of Montana and the US Department of Agriculture and are cleared for travel."

According to Farm Manager Dave



Cronauer, "The Yellowstone bison are one of the only pure bison genetics with no cattle integration, which makes them highly desirable. There is currently only one herd in the United States with Yellowstone genetics, and that is Ted

Turner's herd. These animals will be used for the cornerstone of our herd as we work to develop one of the best herds in the country."

Forest County Potawatomi Community Facebook Live Session Recap - August 26, 2020

Good morning.

Thank you all for tuning in to watch our Facebook update.

As you may know, Milwaukee was supposed to host the Democratic National Convention last week. But because of the ongoing issues with COVID, the convention became an all virtual event and was held online with no in-person activities. It was disappointing, but understandable given current health situation. We were very excited to have the DNC in Milwaukee as it was a great opportunity for the Potawatomi to showcase our historic homeland and the ongoing presence we continue to maintain in the city. However, even though there were no in-person events, Potawatomi was still able to have a presence at the virtual events and highlight our historic and continued connection to Milwaukee.

During a gathering of the Native American Caucus, I provided a welcome and blessing to begin their virtual meeting. It was a great opportunity to remind those present not only of the Potawatomi's historic connection to Milwaukee, but also the deep connections that all of Wisconsin's tribes have in communities across the state. And one of our own tribal youth, Micasslyn Crawford, provided a welcome to a meeting of the Youth Caucus. She spoke in our language and provided some great words about our tribe's history, and thanked them for thinking of our next generations.

Our businesses are continuing to move to their next phases of reopening. On Monday, Potawatomi Hotel & Casino announced that it will no longer limit admission to Fire Keeper's Club members only. Sessions are now open to everyone, age 21 and over.

And good things are continuing to happen at the Potawatomi Farm. Last week, the tribe received several Yellowstone Bison from the Intertribal Buffalo Council. This is very exciting as this addition will allow us to continue to grow our buffalo herd and make it even stronger.

Those good things happening at the Potawatomi Farm are getting noticed. Recently, the Gannett newspaper chain did a feature story all about the Potawatomi Farm. It focused on the sustainable practices that are used at the farm and the healthy, organic products we now provide our community. The story ran in six different daily newspapers across Wisconsin. If you missed it, make sure you look at the latest edition of the Traveling Times and give it a read – it's really a great story.

One last thing before I turn it over to others: Input is still needed for the Pathway to Wellness Bicycle & Pedestrian Plan. A new, shorter survey can be found at the link on the screen (<https://members.fcpotawatomi.com/bike-survey/>).

Family Services has a lot of great updates this week and we need your help!

So, where are we at with child care? We're working diligently on a plan that will allow for reopening Rising Sun Day-care safely. But the short answer is, that timeline remains undefined.

We know you're headed back to work and school, and we are doing our best to ensure appropriate accommodations. We remain in great need of in-home child care providers. If you're interested in becoming a certified child care provider, please contact Kathy Tupper at (715) 478-4433.

We continue to be in need of a few foster homes and/or family placements for some larger sibling groups of school-aged children. Please consider bringing these youth into your home. Contact ICW to become a licensed placement. For those who have turned in their current licensed foster homes and family placements paperwork, Migweth! We're still awaiting some paperwork – please get your completed licensure packets in as soon as possible, and remember that surprise gift card awaits you!

A reminder for those receiving Economic Support services. Your paperwork is due by Aug. 31, 2020. Please get it in this week – or you will experience a lapse in service.

We recognize that in isolated moments, domestic violence, sexual assault, exploitation, child abuse and neglect, etc. may arise. We ARE available and will respond to emergencies and safety concerns accordingly.

If you're feeling suicidal please call for help: 1-800-SUICIDE or 1-800-273-TALK. For non-emergency service requests, our business hours remain to be Monday – Thursday, 7 a.m. – 5 p.m. If you should call outside of these hours, please leave a message with your full name and a WORKING phone number so that we may return your call. Call Family Services at (715) 478-4433.

Assistance is available for qualifying applicants for food, medical and child care expenses. We'd like to invite you to apply at <https://access.wisconsin.gov>. This website will also be available on Facebook after this presentation. However, we also know that filling out large applications can be daunting and overwhelming. You may call (715) 478-4433 or (715) 478-7206 to schedule your private appointment to come and see us at the Family Services Building. IT and Administrative Services Divisions have assisted us in setting up kiosks and we've got staff

prepared to help walk you through the application process.

I'd like you to expect the following process upon arrival to your scheduled slot:

- Your appointment will take about 30-45 minutes and could result in some assistance to get you through these hard times. Please consider taking the time to apply.

- Appointments will be scheduled on the hour from 10 a.m. until 4 p.m. Monday - Thursday. These appointments fill quickly so please call and schedule yours just as soon as you are able.

Hello, FCP Community.

The Incident Command System is at a Level 1 of a virtual Full-Scale Activation.

As students prepare to go back to school, they may find schools operating differently due to COVID-19. Some students may be continuing with online learning while others may be preparing for in-person learning in schools, which may require them to wear face cloth coverings, continue social distancing, and have their temperatures checked daily. Parents can help by teaching and reinforcing everyday preventive actions in keeping your children healthy during this time.

Based on available evidence, most children do not appear to be at higher risk for COVID-19 than adults. While some children and infants have been sick with COVID-19, adults make up most of the known cases to date. Watch your child for any signs of COVID-19 illness such as: Fever or chills, cough, shortness of breath/difficulty breathing, fatigue, muscle/body aches, headache, new loss of taste/smell, sore throat, congestion or runny nose, nausea, vomiting, diarrhea.

Symptoms may appear 2-14 days after exposure to the virus.

For many people, being sick with COVID-19 would be a little bit like having the flu. Most people who have gotten COVID-19 have not gotten very sick. Only a small group of people who get it have had more serious problems.

Parents and caretakers play an important role in teaching children to wash their hands. Explain that hand washing can keep them healthy and stop the virus from spreading to others. Be a good role model – if you wash your hands often, they're more likely to do the same.

Help your child stay active and en-

courage your child to play outdoors—it's great for physical and mental health.

Take a walk with your child or go on a bike ride. Use indoor activity breaks (like stretch breaks or dance breaks) throughout the day to help your child stay healthy and focused, and at all times when out in public, please make sure you social distance from others and always wear a face covering.

If at any time you have an emergency need, please reach out to Emergency Management at (715) 478-4428, and we will either assist or put you into contact with the proper department that fits your needs.

HWC Optical - Dr. Bill Pierre OD

Good morning.

The Optical Department is now open and scheduling appointments. Please call (715) 478-4339 to schedule.

One additional safety measure we have made in the optical department is the purchase and installation of an ultraviolet disinfection unit. This unit allows us to place all frames that have been handled into the unit to assure proper cleaning and disinfecting is complete before placing back on the displays for the next patient. We also continue to wipe down all chairs and equipment between each visit. Your safety and health is our main priority, and we will continue to monitor new guidelines or recommendations as things change.

Even during quarantine, we manage to bend, scratch or break our glasses. Many of you have been patiently waiting for exams as well. We ask your continued patience with us. With the return of optical team members, we are able to keep the dispensary and exam area operating. For that reason, we request that you please call to schedule an appointment to visit even if it is for something in the dispensary. This includes dropping off a repair, picking up contacts, or even selecting a new pair of glasses. When possible, we are leaving items for pick up at the main entrance to the building – this will be communicated to you if that is the case.

As the reopening continues, our intention is to add more staff to be able to continue to meet your needs.

If you are unable to make a scheduled visit, please let us know as soon as you can so we can possibly allow someone else in at that time slot.

Working together, we can continue to address the individual needs for healthy eyes and clear, comfortable vision for the Potawatomi, employees, and the surrounding community, as this department has done for over 19 years.



Good Morning!

I am here this morning to provide you some information regarding the Crandon Off-Road races. While we know the majority of us are race fans including myself, the Health & Wellness Center is in agreement with Mole Lake and their concerns of the number of people descending to our back yard. We anticipate large crowds because of its popularity. During the next week, people will start to arrive by the hundreds from all over the nation. Some will be arriving early in the week, going to your popular lunch site. The closer to the weekend, the larger the crowds. We are strongly encouraging our membership and community to avoid places with large crowds. While recently the virus numbers have been manageable and some of us might feel more confident, there is a lot at stake here.

Both tribes have done a great job to keep the numbers of COVID cases down to low numbers. We don't want this one event to change or undo what we have accomplished so far.

Please. Please. Please. If you don't need to go out next week, stay in. Protect yourself and family. If you must go out, use caution. Wash hands frequently, continue to wear a mask, and stay at a safe distance.

The Health & Wellness Center and Incident Command monitor the number of cases or suspected cases daily. If you should feel sick, please call the Health & Wellness Center. We will direct you where to go and what to do for the protection of all. We have a well-trained staff equipped to process and test as needed. Our concern is a rapid increase in outbreak. We don't want people to be standing in lines.

This will be a true test for all of us! God bless and continue to stay safe.

AN IMPORTANT MESSAGE FROM HEALTH & WELLNESS CENTER:

As of Aug. 3, 2020, the Health & Wellness Center expanded its hours from 7 a.m. – 5 p.m., Monday through Friday. The clinic is also accepting new patients.

As the clinic begins to see more patients for some types of care that have been postponed, know that it continues to take every precaution to keep you safe if your visit requires visiting the clinic. The following changes have been made in an effort to support a safe increase in volumes:

- Curbside COVID-19 testing for those who display symptoms or who have been exposed to someone who tested positive.



Potawatomi Hotel & Casino Opens Reservation System to All

MILWAUKEE (Aug. 24, 2020) – Potawatomi Hotel & Casino is inviting everyone to join in on the fun. The casino will no longer limit admission to Fire Keeper's Club members only. Sessions open to everyone, age 21 and over, began Aug. 24. Guests can sign up for those sessions at paysbig.com.

Reservations are required to enter a gaming session. Non-FKC members will be able to sign up for a free guest account to make those reservations. These spots are limited, so people are encouraged to make their reservations early or sign up for free during open sessions at the casino to become a Fire Keeper's Club member.

Potawatomi will remain open from 9 a.m. to midnight daily, with guests able to make reservations during four differ-

ent, three-hour gaming sessions:

- 9 a.m. - noon
- 1 - 4 p.m.
- 5 - 8 p.m.
- 9 p.m. - midnight

All guests will still be required to wear a mask and have their temperature checked upon arrival. Other health and safety protocols include:

- Plexiglas divider panels were added to slot machines to create a barrier between players.
- Plexiglas divider panels were installed at cashier windows, player's club booths, restaurant host stands, hotel front desk and security desks.
- No smoking is permitted inside the building until further notice.
- Increased frequency of cleaning and

sanitizing has been enacted in all public spaces with an emphasis on high-contact surfaces.

- Hand sanitizer stations are located throughout the property.
- Signage encouraging guests and employees to practice social distancing and proper hygiene is located throughout the property.
- The hotel is open, but limited to 25 percent occupancy.
- Table games, off-track betting, poker and bingo remain closed.
- All restaurants remain closed for dine-in service. Take-out dining is available at RuYi, Fire Pit Sports Bar & Grill and the Canal Street Café.
- The spa, fitness center, retail, valet and banquet services remain closed.

These measures, among others, will remain in place until the science and accompanying data show it's safe to move closer to pre-pandemic operations.

Wisconsin Homeless Veteran Program Receives Federal Support

MADISON, Wis. (Aug. 20, 2020) – The Wisconsin Department of Veterans Affairs (WDVA) has been awarded a grant from the US Department of Veterans Affairs (USDVA) to continue to operate and expand Wisconsin's successful Veterans Housing and Recovery Program (VHRP), which provides temporary housing, training, and supportive services to military Veterans who are homeless or at risk of becoming homeless in order to help them obtain permanent housing.

For more than 25 years, VHRP – through its community partnerships and extensive referral network – has helped homeless veterans in Wisconsin receive

the job training, education, counseling and rehabilitative services they need to obtain steady employment, affordable housing and the skills to sustain a productive lifestyle. As part of the VHRP program, three transitional Veterans Housing Centers located in Chippewa Falls, Union Grove, and Green Bay provide housing and services to 78 Veterans in need.

"It is so important that we support the well-being of our state's vulnerable Veterans," WDVA Secretary Mary Kolar said. "I'm pleased the VHRP will continue to assist at-risk Veterans – men and women – navigate the pathway to stable housing

by providing the tools and support to help put homelessness behind them."

Under the Homeless Providers Grant and Per Diem Program, the USDVA agrees to make a per diem payment to the State for each day a Veteran participates in the VHRP. With announcement of this grant, WDVA will expand services at both the Chippewa Falls and Union Grove locations, adding an additional 18 beds at Chippewa Falls and an additional 10 at Union Grove, allowing housing and other assistance to be provided to at least an additional 28 veterans during this grant cycle. The Union Grove location will also include housing and services for

female Veterans.

The grants, awarded by the US Department of Veterans Affairs, are part of the Grant Per Diem program which provides funding to community organizations that provide transitional housing and supportive services for homeless Veterans, with the goal of "helping homeless Veterans achieve residential stability, increase their skill levels and income and obtain greater self-determination."

Honoring Navajo Code Talkers Day

SANTA FE, N.M. (Aug. 14, 2020) — U.S. Senator Tom Udall (D-N.M.), vice chairman of the Senate Committee on Indian Affairs, issued the following statement to honor the over 400 Navajo Code Talkers whose critical service saved lives and played a pivotal role during World War II:

"Almost 80 years ago, over 400 Navajo men volunteered for Code Talker duty to fight for a country that had not even recognized them as citizens until two decades earlier, even though the Navajo people had lived on these lands since time immemorial. Nonetheless, these brave young men enlisted so they could serve.

"Today, we honor the bravery and service of the Code Talkers, who saved lives and played a critical role in U.S. military efforts in the Pacific theater during World War II. On the battlefields, as they risked their lives, they relayed countless messages in Navajo code with critical information in quick succession.

Their code was never broken. In the Navajo Code, the word for America was 'our mother.' As one Code Talker has explained — 'Our Mother' stood for freedom — our religion — our ways of life. And that's why we went in.' The Navajo Marines identified their culture with their country. When they fought, they fought for both.

"Our country owes these heroes a debt that we can never repay. Even upon their return, the Code Talkers have continued to serve our country and their communities as leaders, health care workers and so much more. Four of the Code Talkers are still with us today—Thomas H. Begay, John Kinsel, Sr., Samuel Sandoval and Peter MacDonald, Sr. Today, we honor the service of these four men and the service of more than 400 brothers who sacrificed at a critical time for the security of our nation and the world.

"We can never thank you enough. But from the bottom of my heart, I join a grateful nation to say – ahéhee."

Unity Fire MKE: EARTH, WIND, FIRE, WATER

Prayer - Reflection - Hope. A fire with intended purpose burned brightly day and night for four consecutive days in peaceful prayer for Mother Earth and for her people who seek peaceful change. Each day focussed on the four elements of life: Day 1 - Earth, Day 2 - Wind, Day 3 - Fire, Day 4 - Water.

On Monday, August 17, 2020, Healing Intergenerational Roots Wellness Institute (HIRWI) opened the Unity Fire MKE with a message that inspired the community to move to action. The day's events honored the feminine and the attendees participated in a "Healing with Red Sands Ceremony" that was led by CEO & Founder Lea Denny to honor those who are still missing and those who were taken too soon from our communities. HIRWI staff members, Jamie Kellicut and Malia Chow, offered words of hope and expression of the seriousness of this issue. Two indigenous women community members moved the audience with their passion and work around missing and murdered Indigenous women. Dr. Jeneile Luebke spoke of her research on Intimate Partner Violence against native women and Jenna Knueppel described her "red dress" display that can be viewed over the course of the Unity Fire. HIRWI is a social justice-informed and culturally rooted Intergenerational Healing Approach™ that improves mental health and wellness outcomes for Indigenous and underserved communities.

The fire took place at the Wgema Campus, hosted by Forest County Potawatomi, during the Democratic National Convention, August 17-20, 2020. Mark Dennings, the organizer of the event said, "We're affected by so many issues that marginalize communities are affected by, that we wanted to make our presence known but we also wanted to bring up the leadership that is so needed in our communities virtually and in person. We're thinking about them. We want them to do well. This fire is about prayers and reflections, that they do well – that they think about us – all of us in this country."

Native Americans tended the fire and conducted tobacco, water and pipe ceremonies daily. The Unity Fire MKE was done for the community's healing, unity and safety for all, but especially for our elders and children. Social distancing, wearing of masks, and other health protocols applied at all times.
